Welcome to Season 69. As you know, FSLT is run totally by volunteers. I'd like to mention just two of them. These gentlemen have given of their time and talents for many years. One has been involved for 30 plus years, initially as a performer and then as a valuable friend and regular volunteer. He prepares the lobby for Opening Night Galas, arranges beautiful bouquets in keeping with the theme of each show, makes sure we are fully stocked with paper goods, runs random errands, serves as our liaison with the security alarm company, is "keeper of the keys," and first in line to open the theatre for repairmen.
